ANTICIPATED NEED:

The CSUN Department of Journalism is seeking a part-time faculty member to teach our practicum class (JOUR 397) beginning in Fall 2024 and to serve as adviser of the student newspaper, the award-winning Daily Sundial. The class, with a maximum 20 students, is taught in-person Mondays 10-11:40 a.m. in the fall and spring semesters. The academic appointment begins Aug. 21, 2024. This course requires additional time beyond classroom teaching, which is approximately 21.3 hour per week and will include assisting students in the campus newsroom for at least six hours, in addition to conducting office hours, grading, and class prep. Instructional pay ranges from \$16,022.40 to \$22,800.00 total per semester paid in six monthly checks. Additional compensation will be given for advising students who are employed as editors, conducting pre-semester student-training workshops, accompanying students to conferences, applying for grants and submitting student journalism contest entries, etc. A bachelor's degree in journalism or a related field and prior professional newsroom experience is required. Ability to work with students from diverse backgrounds is also required. Teaching experience and/or prior student media adviser experience is desirable. The University offers excellent fringe benefits. Interviews will take place in early July, with pre-semester work to begin in early August.

Note: All part-time faculty appointments are temporary and do not confer academic rank. Final determination of part-time teaching assignments is contingent upon student enrollment figures and funding. Some courses are taught in-person, while others are taught in a hybrid formant (half in-person, half online), and others are fully online. Prior online teaching experience is desired for classes that are hybrid or fully online. In addition to teaching, the position requires weekly office hours and participation in assessment of student learning. The successful candidate will be held to the standards and requirements

of the college and department in which he/she/they is/are employed. Given CSUN's commitment to excellence in teaching, research, and engagement in a diverse environment, the successful candidate will help the Department achieve equitable academic outcomes for all students through teaching, student mentorship, and scholarship.

Application Process:

Applicants must submit a cover letter, resume, samples of published work and references to the email address in the section below. The cover letter should describe contributions to diversity and inclusiveness. The resume should include educational background, prior teaching experience (specifying in-person and/or online), and related professional experience.
