Qualifications: Assistant Learning Specialist must meet the following qualifications: Must be currently enrolled graduate student and be registered or admitted at CSUN; have a minimum 3.0 GPA (cumulative); Experience working with culturally diverse populations. Preferred qualifications include previous mentoring experience, and experience with student-athletes.

Responsibilities: Assistant Learning Specialist will work with student-athletes 1-1 or in a small group setting. Mentor students in study skills, time management, and other topics as assigned by the department. Help student-athletes learn to effectively balance the demands of their academic and athletic responsibilities. Help student-athletes understand their learning strengths in order to develop short and long-terms goals related to academic achievement and personal growth. Help student-athletes utilize technology, campus/community resources, and effective strategies to become self-sufficient learners. Communicate with Learning Specialist and Athletic Academic Advisors to discuss student-athletes' progress and development. Complete reporting for each scheduled session using online reporting system, participate in mandatory staff meetings and trainings, report to work on time and adhere to schedule. All ISAs are required to undergo NCAA compliance rules training with the expectation that parameters will be followed, and compliance concerned will be reported immediately to their supervisor. Maintain a respectful and professional attitude at all times. Hours can range from week to week with general need communicated to each ISA individually based on area of expertise.

*Appointments are for single term only. Returning ISAs must apply every term to be considered. Renewal is not guaranteed. Winter and Summer needs are limited. Course specific coverage dependent on student-athlete enrollment.

<u>Please note:</u> Students applying for Instructional Student Assistant positions must be admitted or registered as a CSU student. Under supervision, Instructional Student Assistants in this classification perform teaching, grading or tutoring duties for the majority of work hours in a given appointment in a given academic

department or equivalent administrative unit over the course of an academic term. The work may be performed on-campus or at an off-campus public agency or private non-profit organization under an agreement with a campus in the CSU system. Academic Student Employees may not concurrently hold a faculty or staff position. Students with assignments in more than one student classification (i.e. Teaching Associate and Graduate Assistant) are restricted to working a maximum of 20 hours per week total during the Academic Year and up to full-time during academic break periods. The 20 hour per week maximum includes hours worked in all positions.
