

ANNUAL REPORT OF SEXUAL MISCONDUCT

Reporting Period July 1, 2015 - June 30, 2016

- 1) Total pending reports as of July 1, 2015: 1
- 2) Total reports of sexual misconduct, dating/domestic violence, and stalking: 141
- 3) Number of reports of sexual misconduct, dating/domestic violence, and stalking received in which the Respondent's status is:

a. Student: 61b. Employee: 2c. Third Party: 54d. Unknown: 24

- 4) The number of sexual misconduct, dating or domestic violence, and stalking <u>complaints filed</u> with the Office of Equity and Diversity: 17
 - a. 3 complaints were constructively withdrawn during the course of the investigation when the Complainant (or both the Complainant and Respondent) separated from the university, disengaged from the process, and did not provide information sufficient to continue a full investigation
- 5) The number of sexual misconduct, dating/domestic violence, and stalking reports <u>with</u>
 completed investigations¹ (defined as cases in which a full investigation was conducted and completed with formal report of findings): 14
 - a. 5 insufficient evidence to find violation (1 case was referred to student conduct for further adjudication of misconduct not based on protected status)
 - b. 9 violations of CSU EO 1097 (2 of the 9 currently pending appeal determination)
- 6) The number of sexual misconduct, dating/domestic violence, and stalking <u>reports resolved</u> <u>without **completed** investigations</u>, including a description of the resolution and/or reason for no investigation:
 - a. 127
 - 14 anonymous reports and 78 reports in which the Respondent's identity was unknown or not disclosed by the Reporting Party, or the Respondent was a third party not affiliated with the university
 - ii. 8 early resolutions (achieved in accordance with the complainants' requests: 5 No-Contact Directives; 1 placing respondent on notice of unwelcome behavior and "cease and desist" conversation; 1 placing respondent on notice of unwelcome behavior and "cease and desist" conversation with additional training provided by Title IX Coordinator; 1 allowing complainant to switch classes)

¹ Regardless of whether investigations were initiated, partially conducted, or completed, all reporting parties/victims/survivors/complainants were provided with their written rights and options and resources.

- iii. 27 reports in which the Reporting Party was unresponsive and/or expressed that they did not want the university to conduct an investigation, and the university determined that the risk posed to the reporting party and campus did not outweigh respect for the reporting party's wishes; and insufficient information to conduct/complete an investigation
- 7) The number of sexual misconduct, dating and domestic violence, and stalking investigations in which the <u>Respondent was held responsible</u>, including a description of final sanction:
