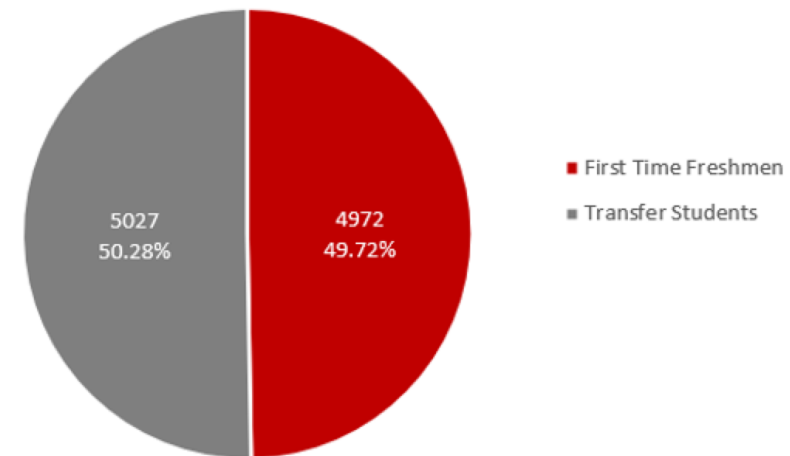
# ARTICULATION

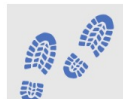

## POLICIES FOR COMMUNITY-ENGAGED LEARNING

- EO 1064: Specifies requirements of supervision and risk management
- Campus policies: Further define requirements, particularly academic
- Risk Management required for all off-campus activities required in a class
  - Field Trips
  - Internships for Academic Credit (AINT course attribute)
  - Community-based (Service) Learning (CSLI & CCEL course attributes)

## KEY REQUIREMENTS

- Approved community-partner with Risk Assessment Completed (at least once every 5 years)
  - CP agreement NOT required for Paid Internships but Risk Assessment required
- Student Learning Plan, Liability Release, Evaluations, Hours Tracked
- S4 – data manager supported by CSU CO, UGS & OCE
  - In use NOW for all CBL
- S4 coming for Academic Internships
