### Class Search Functions Updated

Matador Academic Challenge

- Matador Academic Challenge is now open to all students!
- Students taking 15-units or more may drop a class without a justification, during weeks 5-11.
- Students need to fill out this <u>Matador Academic Challenge</u> <u>Form</u>.
- Other conditions impacting students:
  - May not drop below 12-units
  - May not withdrawal from Basic Skills math or writing.
  - Will receive a grade of "W" on their transcript.
  - The grade of "W" may impact *Satisfactory Academic Progress* for financial aid recipients.

## Proposed Attendance Policy from EPC

#### **Attendance (Class Attendance)**

Attending classes helps students keep up to date with material, realize expectations, and foster interactions that promote connections for student success. Students are encouraged to attend class and expected to meet the attendance policies as outlined in course syllabi and follow university guidelines. Clear communication (in-person, email, or voicemail) with instructors about temporarily missing a class(es) enables instructors to advise students about continuing in the class successfully. If no instructor is assigned students should communicate with the department chair. A reminder that missing class is different from withdrawing from a class.

Note: Will be presented at Faculty Senate in September as a first read.

### AB 928 Status Update

- Goal: improved transfer success, achieve streamlined transfer, more Associate Degrees for Transfer.
- Requires common transfer (GE) pathway among CSU, UC, and CCC.
- Cal-GETC will be used at CCC as of Fall 2025
- EPC will be working in Fall 2024 to solidify the CSUN plan for Cal-GETC and the revised CSU General Education Policy.

- <u>CSUN Blended Undergraduate/Graduate Degree</u>
  <u>Program Policy</u>
- Updated: <u>Credit Certificate Policy</u> Changed "University Certificate" to "Graduate Certificate" and created a new type of certificate called "Postbaccalaureate Certificate" to allow 300-level courses.
- Updated joint EPC/GSC Policy: <u>Academic Credit for</u> <u>Prior Learning, Knowledge, and Experience</u> and related policies.

# PP&R Updates

For 2024-25

• New Preamble added to Section 700. Details in next slide.

- New Preamble added at the beginning of Section 600
  - To emphasize the importance of the university's Diversity, Equity, Inclusion, Justice, and Accessibility values when interpreting policy
  - The Preamble also provides specific definitions for each of these values, as a guide for interpreting existing policy, some of which already refer to "equity and diversity" but did not define what that means.

#### Updated Equity Language for Recruitment (621-622):

- This policy updates the language to clearly convey the right of every member of our campus community to "work, live, and learn in an environment free from discrimination based on a protected status."
- The prior language was more passive and vague.

#### Performance Standards and Monitoring (603.9.2):

- DPCs are now required to articulate, in the Personnel Procedures, their department's understanding of what constitutes a predatory journal, with regards to their requirements for scholarship.
- The policy also reminds faculty that it is their responsibility to understand and become familiar with those department expectations and the areas of concern in their discipline, so that they can avoid unintentional missteps in publishing.

#### • General Obligations (612.1):

- This policy reminds departments that the preferred order for personnel committee elections is CPC, then DPC. This is to ensure timely completion of elections by the respective deadlines.
- Departments can deviate from this preferred order so long as they still meet the calendar deadlines for these committee elections.

#### **College Level (Personnel Committee)** (612.4.1):

- This policy requires that the election of CPCs be concluded by the end of the third week. This is to ensure that the appropriate committees are in place and ready to process sabbatical applications as well as 2<sup>nd</sup> year probationary faculty RTP files.
- This policy change brings the text of Section 600 into alignment with the Section 600 Academic Year Calendar of Personnel Procedures which already has a third week deadline.

#### • **Appeals** (660):

- This policy update clarifies two issues:
  - Defines what is an appeal. This definition was missing in Section 600.
  - Clarifies the reasons for which a faculty member can appeal a negative RTP recommendation to PP&R.

#### **Sabbatical Leave** (672.4):

- This policy update makes explicit that the Sabbatical Leave Report will be made more broadly available to the following:
  - The Dean
  - Professional Leave Committee, and
  - The Provost.
