## OVERVIEW

The Business Law minor allows non-majors to pursue secondary studies in Business Law. Increasingly, businesses face an overall risk of liability arising from their roles as employers, sellers, buyers and investors. Additionally, companies seeking to expand into international markets or to enter the stream of e-commerce are faced with various legal and regulatory issues,

ranging from contracting, product liability and marketing to intellectual property licensing, consumer privacy and employee rights. The Business Law program prepares students to analyze complex problems, think critically, and communicate effectively while learning the legal principles of business decisions.
