Concerns have been communicated from the campus about completing the reviews, since the campus has now moved to virtual modalities for the remainder of the semester, due to health concerns with the COVID-19 pandemic. After discussion, the committee acted on the following motion:

MSP: That the Provost will confer with CFA to extend the deadlines for Post Tenure Review with the approval of PPR.

Inquiry from the David Nazarian College of Business and Economics regarding peer class visits, Tenure Track and Lecturers
 Judy Schmidt-Levy updated the committee on an inquiry received from the Dean of the David Nazarian College of Business and Economics. Departments are concerned that the peer class visits for faculty under review may be negatively impacted due to the move to

virtual modalities for the rest of the semester. This is due to health concerns related to the COVID-19 pandemic. This is for both Tenure-Track and Lecturer faculty. After discussion, the committee acted on the following motion:

MSP: Pending the Provost speaking with the Chancellor's Office to meet and confer with the California Faculty Association, PPR proposes that the spring, 2020 peer evaluation of tenure-track and non tenure-track faculty be extended until fall, 2020.
