Subject: Revised: Eligibility for Consideration for Range Elevation – Effective Fall 2024

Our records indicate that you may be eligible for consideration for a Range Elevation (subject to final review) pursuant to Article 12.16 – 12.20 of the current Unit-3 Faculty Collective Bargaining Agreement (CBA). "Those eligible for lecturer range elevation shall be limited to lecturers who have no more eligibility for salary increases pursuant to provision 12.10 in their current range [rank], and have served five (5) years in their current range [rank]." Range elevation for lecturers shall be accompanied by advancement of at least five percent (5%) on the salary schedule (Article 31.6). Please note: All temporary faculty from prior eligibility lists may apply. If you do not apply in this cycle you will remain eligible to apply in future cycles. No further notification will be sent to you about your continued eligibility.

Critical Deadlines - Dates Revised due to CSUN holiday closings.

- November 12, 2024 Lecturer submits written request for consideration to Department Chair.
- November 27, 2024 The Department Chair will notify the applicants in writing of his/her recommendation.
- <u>December 20, 2024-</u> The Dean has final approval authority and must provide written notification to lecturer of his/her decision.

In accordance with Article 12.18 of the CBA, please be advised that receipt of a previous FMI (Faculty Merit Increase) may affect your eligibility for Range Elevation.

If you wish to be considered for a Range Elevation effective at the beginning of the Fall 2024 semester, please submit a completed <u>Request for Consideration for Range Elevation Application</u> to your <u>Department Chair along with your Personnel Information File (PIF) by November 12, 2024.</u> You should receive a copy of the Department Chair's recommendation by <u>November 27, 2024</u> and notice of the Dean's decision by <u>December 20, 2024</u>.
