Note: All part-time faculty appointments are temporary and do not confer academic rank. Final determination of part-time teaching assignments is contingent upon student enrollment figures and funding.

Current Courses or Specialization

Detailed examination of the foundational ideas and issues of the urban planning profession drawn from planning history, alternative models of planning and planning ethics. Rational, incremental, advocacy and participatory theories are examined with a focus on techniques for increasing citizen participation.

Planning principles will be examined in the context of case studies drawn from the Los Angeles region, the U.S. and world cities.

Planning background is also provided by evaluating general plans and zoning requirements. Resume writing, networking, and informational interviewing assignments enhance students' professional development.

Qualifications

Completion of a master's degree is required, Ph.D. desired, in urban studies, planning (city, urban, regional, etc.), or a closely related field.

Prior university or college-level teaching experience desired with positive teaching evaluations.

Ability to teach/mentor a diverse student population.

Experience using learning management software (e.g. Canvas) and remote/virtual teaching technologies (e.g. Zoom) desired.

Salary Range

Placement into a salary range/rank is based on qualifications, experience, and degree completion.

The Lecturer A/Rank 2 base salary range is \$4,530 to \$5,404 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$4,530, multiplied by time base for a 3-unit course, 0.2, this will be \$906 per month paid in 6 monthly checks. The total semester salary is \$5,436.

The Lecturer B/Rank 3 base salary range is \$5,405 to \$6,786 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$5,405, multiplied by the time base for a 3-unit course, 0.2, this will be \$1,081 per month paid in 6 monthly checks. The total semester salary is \$6,486.

Application Process:

Applicants must submit a current resume and a cover letter which describes their qualifications, designates the specific courses they are interested in teaching, and whenever possible, times available for teaching assignments. The resume should include educational background, prior teaching experience, evidence of scholarship, and/or related professional experience. In later phases of the search process, applicants may be requested to provide verification of terminal degrees, licenses and certificates.
