# **Current Courses or Specialization**

The study of current urban design techniques and policies and their application to local communities and neighborhoods.

Digital tools and computer aided design will be utilized for site planning. Local communities will be involved in the urban design process utilizing various community participation techniques, as the class collaborates to develop the final site plan.

### **Qualifications**

Completion of a master's degree is required, Ph.D. desired, in urban studies, planning (city, urban, regional, etc.), or a closely related field.

Prior university or college level teaching experience with positive teaching evaluations is desired.

Ability to teach/mentor a diverse student population.

Experience using learning management software (e.g. Canvas) and remote/virtual teaching technologies (e.g. Zoom) desired.

# Salary Range

Placement into a salary range/rank is based on qualifications, experience, and degree completion.

The Lecturer A/Rank 2 base salary range is \$4,530 to \$5,404 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$4,530, multiplied by time base for a 3-unit course, 0.2, this will be \$906 per month paid in 6 monthly checks. The total semester salary is \$5,436.

The Lecturer B/Rank 3 base salary range is \$5,405 to \$6,786 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$5,405, multiplied by the time base for a 3-unit course, 0.2, this will be \$1,081 per month paid in 6 monthly checks. The total semester salary is \$6,486.

### **Application Process:**

Applicants must submit a current resume and a cover letter which describes their qualifications, designates the specific courses they are interested in teaching, and whenever possible, times available for teaching assignments. The resume should include educational background, prior teaching experience, evidence of scholarship, and/or related professional experience. In later phases of the search process, applicants may be requested to provide verification of terminal degrees, licenses and certificates.
