Salary Range

Advanced seminar on contemporary topics in urban studies and planning. Students are required to produce a culminating research project.

Completion of a master's degree is required, Ph.D. desired, in urban studies, planning (city, urban, regional, etc.), or a closely related field.

Placement into a salary range/rank is based on qualifications, experience, and degree completion.

Prior university or college level teaching experience desired with positive teaching evaluations. Professional experience in planning is desired.

The Lecturer A/Rank 2 base salary range is \$4,530 to \$5,404 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$4,530, multiplied by time base for a 3-unit course, 0.2, this will be \$906 per month paid in 6 monthly checks. The total semester salary is \$5,436.

Ability to teach/mentor a diverse student population.

Experience using learning management software (e.g. Canvas) and remote/virtual teaching technologies (e.g. Zoom) desired.

The Lecturer B/Rank 3 base salary range is \$5,405 to \$6,786 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$5,405, multiplied by the time base for a 3-unit course, 0.2, this will be \$1,081 per month paid in 6 monthly checks. The total semester salary is \$6,486.

Application Process:

Applicants must submit a current resume and a cover letter which describes their qualifications, designates the specific courses they are interested in teaching, and whenever possible, times available for teaching assignments. The resume should include educational background, prior teaching experience, evidence of scholarship, and/or related professional experience. In later phases of the search process, applicants may be requested to provide verification of terminal degrees, licenses and certificates.
