**Note:** All part-time faculty appointments are temporary and do not confer academic rank. Final determination of part-time teaching assignments is contingent upon student enrollment figures and funding.

# **Current Courses or Specialization**

Upon prior approval by the internship coordinator, students may earn up to 6 units for professional experience in a planning department, social service agency or other public or private organization dealing with urban problems.

The course will focus on professional preparation and ethics of professional practice in urban studies and in urban planning.

### Qualifications

Completion of a master's degree required, Ph.D. desired, in urban studies, planning (city, urban, regional, etc.), or a closely related field.

Prior university or college level teaching in planning/urban studies with positive teaching evaluations desired.

Ability to teach/mentor a diverse student population.

Experience using learning management software (e.g., Canvas) and remote/virtual teaching technologies (e.g., Zoom) desired.

## Salary Range

Placement into a salary range/rank is based on qualifications, experience, and degree completion.

The Lecturer A/Rank 2 base salary range is \$4,530 to \$5,404 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$4,530, multiplied by time base for a 3-unit course, 0.2, this will be \$906 per month paid in 6 monthly checks. The total semester salary is \$5,436.

The Lecturer B/Rank 3 base salary range is \$5,405 to \$6,786 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$5,405, multiplied by the time base for a 3-unit course, 0.2, this will be \$1,081 per month paid in 6 monthly checks. The total semester salary is \$6,486.

#### **Application Process:**

Applicants must submit a current resume and a cover letter which describes their qualifications, designates the specific courses they are interested in teaching, and whenever possible, times available for teaching assignments. The resume should include educational background, prior teaching experience, evidence of scholarship, and/or related professional experience. In later phases of the search process, applicants may be requested to provide verification of terminal degrees, licenses and certificates.
