Courses or Specialization

This course focuses on the study of human behavior as it is affected by basic human needs and urban conditions. Special attention will be given to: (1) the manner in which local neighborhoods and communities are integrated into the planning process and how needs are articulated; and (2) the manner in which local economic development can be affected by the planning process and by the integration of community participation.

Supporting field trips and discussions with planners and project managers are planned.

Qualifications

Completion of a master's degree required, Ph.D. desired, in urban studies, planning (city, urban, regional, etc.), or a closely related field.

Prior university or college level teaching in planning/urban studies with positive teaching evaluations is desired.

Professional experience as a city, urban, or regional planner preferred.

Ability to teach/mentor a diverse student population.

Experience using learning management software (e.g., Canvas) and remote/virtual teaching technologies (e.g., Zoom) desired.

Salary Range

Placement into a salary range/rank is based on qualifications, experience, and degree completion.

The Lecturer A/Rank 2 base salary range is \$4,530 to \$5,404 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$4,530, multiplied by time base for a 3-unit course, 0.2, this will be \$906 per month paid in 6 monthly checks. The total semester salary is \$5,436.

The Lecturer B/Rank 3 base salary range is \$5,405 to \$6,786 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$5,405, multiplied by the time base for a 3-unit course, 0.2, this will be \$1,081 per month paid in 6 monthly checks. The total semester salary is \$6,486.

Application Process:

Applicants must submit a current resume and a cover letter which describes their qualifications, designates the specific courses they are interested in teaching, and whenever possible, times available for teaching assignments. The resume should include educational background, prior teaching experience, evidence of scholarship, and/or related professional experience. In later phases of the search process, applicants may be requested to provide verification of terminal degrees, licenses and certificates.
