Understanding issues of zoning, eminent domain, and takings effect what is permissible in plans. Planners also need to consider First Amendment and exclusionary zoning issues.</p>	<p>Completion of a master's degree required, J.D., or Ph.D. desired, in urban studies, planning (city, urban, regional, etc.), or a closely related field.</p> <p>Prior university or college level teaching in planning/urban studies with positive teaching evaluations is desired.</p> <p>Professional experience in planning and land use law preferred.</p> <p>Ability to teach/mentor a diverse student population.</p>	<p>Placement into a salary range/rank is based on qualifications, experience, and degree completion.</p> <p>The Lecturer A/Rank 2 base salary range is \$4,530 to \$5,404 monthly. Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$4,530, multiplied by time base for a 3-unit course, 0.2, this will be \$906 per month paid in 6 monthly checks. The total semester salary is \$5,436.</p>

Teaching 3 units equates to a 0.20 time base (3/15). Calculated at the entry level salary of \$5,405, multiplied by the time base for a 3-unit course, 0.2, this will be \$1,081 per month paid in 6 monthly checks. The total semester salary is \$6,486.</p>

Application Process:

Applicants must submit a current resume and a cover letter which describes their qualifications, designates the specific courses they are interested in teaching, and whenever possible, times available for teaching assignments. The resume should include educational background, prior teaching experience, evidence of scholarship, and/or related professional experience. In later phases of the search process, applicants may be requested to provide verification of terminal degrees, licenses and certificates.
