

# Telling Lies for Christ

More than 40 percent of the adult population in the United States believe that Noah's flood was global, that this flood deposited the sedimentary layers in the Grand Canyon, and that the Earth is 6,000 years old. All above referred to Christians, who have promoted their false views, are “telling lies for Christ” and doing that with complete sincerity that they cannot be wrong.

In this article I am adding an example of Bruce Malone who is also a Christian and who claims to be a science expert. He has a ministry called "Search for Truth Ministries" in which he sells his books and also DVDs called "The Rocks Cry Out." In a YouTube video titled “Proof of Creation”

he is interviewed by Sid Roth in a 28-minute program. In this video Malone claims to have ten scientific facts that I list in the following paragraphs and then provide responses with my articles and links which give evidence that his science is totally wrong.

**First:** Noah’s flood was global.

**Response:** There is scientific evidence that Noah’s flood was local in southeastern Mesopotamia in ancient biblical time but not global. See these three articles and links.

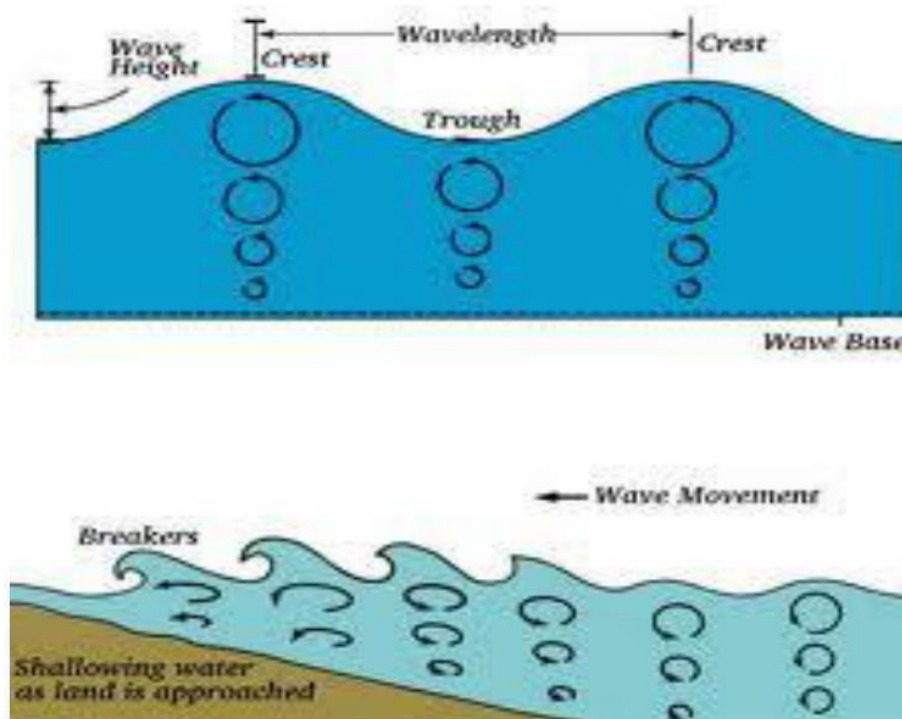

The following image (**Figure 1**) clearly shows that Noah's flood cannot be global because no matter how powerful a storm was that produced this flood, the ocean waves generated by it have circular motions with no significant lateral translation of the water molecules that can erode and move sedimentary particles or suspend them for transport across great distances, say as far as the Grand Canyon.

**Second:** This flood deposited the sedimentary layers in the Grand Canyon about 4,500 years ago in a rush of water, draining

off mountains when the mountains were suddenly raised at the end of the flood.

**Response:** There is no evidence of nearby ancient mountains adjacent to the Grand Canyon that raised up and caused rushing water to carve the canyon. The following articles show that the Coconino Sandstone in the Grand Canyon is eolian in origin and was not deposited in Noah's flood. Desert deposits cannot form in the middle of a flood.

**Third:** The Earth is 6,000 years old.

**Response:** There are many kinds of scientific evidence that the Earth is billions of years old. See the following.

**Fourth:** Bones of dinosaurs that Malone says are supposedly millions of years old contain soft tissue which he believes makes them buried by Noah's flood.

**Response:** Soft tissue in bones occurs because it is enclosed in bone and keratin where bacteria, water, and oxygen cannot penetrate to destroy the tissue and the tissue is degraded and not exactly in the same composition as once existed. **Fifth:** Evolution does not exist because there are no fossil links between kinds of animals.

**Response:** See a book by Samuel Wilkinson written in 2024 with the title of **What Evolution and Human Nature Imply PURPOSE**. It provides multiple kinds of evidence that evolution of life is real and was God's method of creation. Moreover, missing fossil links are found, although scarce, to show that evolution does occur. **Sixth:** Layers of sediment deposited by the eruption of Mt. St. Helens is evidence for rapid deposition.

**Response:** Mt. St. Helens is a volcano that erupted and deposited layers of volcanic ash quickly, but that is not proof that all layered sediment in the Grand Canyon and around the world was deposited quickly. It just shows that catastrophic events can occur in geologic history. Although early geologists postulated the uniformitarianism theory that the same natural laws and processes that operate today on Earth (say the deposition of sediments slowly by streams) have always operated in the past everywhere, but in the last 100 years it has been recognized that uniformitarianism is not always true. In some places, as at Mt. St. Helens, catastrophic events could occur to produce large thicknesses of layered rock relatively quickly. Therefore, careful studies of rock layers need to be done to determine their true origin of deposition. The following article includes a study of the eruption of Mt. St. Helens and its cause for a sudden explosive eruption.

The following article gives an example of the Mancos Shale which is more than 3,000 feet thick and had to be deposited very slowly. Also, in some places, volcanic ash layers and clay layers in shale beds are interlayered and cannot be deposited by rushing waters in separate layers because rushing waters would mix the ash and clay particles.

**Seventh:** Traces of carbon-14 in dinosaur bones indicate that they were buried in Noah's global flood.

**Eighth:** American Indians have a record that such a flood existed.

**Response:** All nations around the world have records of large floods at some time, but they are all different times. Examples are the Deucalion floods in countries bordering the Mediterranean Sea in Bronze age time and ancient and modern major floods of the Yangtse River in China that have killed 2 million Chinese people.

**Ninth:** Noah's ark remains can be found on Mt. Ararat above 14,000 feet.

**Response:** Actually, no remains of Noah's ark have been found on Mt. Ararat, but supposed fossilized remains of Noah's ark have been found several kilometers southwest of this mountain at an elevation of more than 5,000 feet above sea level. Scientific evidence shows that this site is a natural geologic structure that has a streamlined shape of a boat. This structure just coincidentally has a length of about 515 feet which is the



same length as 300 Egyptian cubits, which is the reported length of Noah's ark in Genesis. See the following articles and links.

**Tenth:** Seashells are found on Mt. Everest.

**Response:** This does not mean that water in Noah's flood was so deep that it deposited seashells that reached depths of 29,031 feet, which is the elevation-top of Mt. Everest. The seashells are there because plate tectonics thrust seashell-bearing limestones that were once south of India to be moved and lifted to their present position bordering China.
